PIDC 2008 Registration Procedure

Phase 1: Institution Registration/Early Registration

Duration: January 7 to February 20, 2008

On **January 7, 2008** online pre-registration at www.pidc-online.com will be opened.

- Institutions should visit the site's registration page to reserve the number of teams they will be sending. **Following the N-rule, a team should be composed of three (3) debaters and one (1) adjudicator.** During the early registration period, each institution can reserve slots for a maximum number of six (6) teams. Please note that PIDC 2008 strongly encourages complete teams to participate in the tournament; failure to meet the required number of adjudicators would mean that your institution must still pay the fees corresponding to the missing adjudicator/s.
- Half of the institution's total registration fee (PhP 1,000.00/person) should be paid by **February 15, 2008** through the following account:

Alternatively, you may send a fax copy through (+632) 551-5875. **All deposit slips must be sent by February 20, 2008. A verification email or text message will be sent by the PIDC 2008 Communications Director to confirm the number of slots your institution has secured.**
- Please note that **slots will be on a first-come-first-serve basis.** Failure to meet the deadline for one or both requirements would mean that the slot/s of your institution will be made available for others who would want to expand their participating roster.

Phase 2: Team Registration/Regular Registration

Duration: February 20 – March 31, 2008

- Institution representatives must accomplish the team registration forms with the appropriate information for each team member (including adjudicators) at the registration section of www.pidc-online.com.
- Submit accomplished forms for all respective teams through www.pidc-online.com or as email attachments to pidc2008@gmail.com. **A confirmation email or text message from the PIDC 2008 Communications Director will be sent to verify receipt of these registration forms.**
- The remaining half of the total registration fee (PhP 1,000.00/person) for the institution may be paid until **March 31, 2008** through the following account:

Phase 3: On-Site Registration

Duration: April 3, 2008

- All pending requirements, such as unpaid balances, copies of deposit slips, incomplete forms, etc., should be settled at the registration booth during the first day of the tournament. **Once cleared by the registration committee, a receipt will be issued per institution, and IDs and tournament kits for the entire contingent will be distributed.**
